REAL PROPERTY

The following described real property was inherited by claimant from his deceased uncle, Sarkis Effendi Yanuk Garabed Torosian:

1. A three-story residence of stone and limestone construction, located in Bournjian Mahalle, on the north corner of the street known as Toros Oglu Poonari, in Fenese, Develou Kaza, Kaisaria Sanjak, Angora Vilayet, Turkey. This house contained large storage rooms on the first floor, four rooms on the second floor and three rooms on the third floor; and was surrounded by a large yard. This property was bounded on the north by a street, and across the street was Garabed Agha Chechenian's house; on the east by a road, and across the road was Setrak Semizian's house; on the south by another house owned by said Setrak Semizian; and on the west by the house of Haji Surapion Torosian.
